# What personal information do we collect

- to comply with a legal or regulatory obligation
- to supervise our site and for purposes of such operations as technical troubleshooting, analysis, testings, statistic and survey purposes

## Marketing and communication

We will always seek your consent before doing so, and you can opt out at any time by contacting us on the details under the "Contact us" section of this policy. # How do we store your personal information

If you submit your information but you decide not to use our company's services, all personal data we have collected from you will be deleted after 12 months. If you do use our services, by law, we are required to store your personal data in compliance with our statutory and contractual obligations. You maintain the right to request the deletion of your personal data from our storage



records subject to our company's statutory and contractual obligations.

Your personal data's security is very important to us. This is why, where it's appropriate, our Sites use Hypertext Transfer Protocol Secure (HTTPS) to help keep information about you secure. #### **Subject access requests**

We may need to request specific information from you to help us confirm your identity and ensure your right to access your personal data (or to exercise any of your other rights). This is a security measure to ensure that personal data is not disclosed to any person who has no right to receive it.

We respond to all legitimate requests within one month. Occasionally, it may take us longer than a month if your request is particularly complex or you have made a number of requests. In this case,



we will notify you and keep you updated.
